# To make an application for a Visitor's Visa or Permit <u>or</u> a Limited Purpose Visa or Permit you will need to supply:

- a completed, signed Application for Visiting New Zealand (NZIS 1017) form
- the application fee (see our leaflet New Zealand Immigration's Guide to Fees (NZIS 1028))
- your passport (must normally be valid until at least 3 months past the date you plan to leave New Zealand)
- a recent passport size photograph
- evidence of your financial support while in New Zealand. This may be:
- NZ \$1000 per each person for each month, or
- NZ \$400 for each person for each month if your accommodation is already paid (you will need to show evidence, such as prepaid hotel vouchers)
- Evidence of funds can be in the form of traveller's cheques, bank draft, letters of credit or a bank statement in your name. Cash or credit cards may be accepted as evidence of funds.
- If you do not have the required funds, you will need a guarantee of accommodation and maintenance from a New Zealand citizen/resident friend or relative who lives in New Zealand and is able to be your sponsor. Your sponsor should complete the *Sponsorship Form for Visiting New Zealand* (NZIS 1025).

#### For a Visitor's Visa or Limited Purpose Visa you may also be asked to supply:

• evidence of onward travel

- valid ticket to a country to which you have right of entry, or
- guarantee of repatriation from a New Zealand citizen or resident friend or relative who lives in New Zealand and is able to be your sponsor. Your sponsor should complete the *Sponsorship Form for Visiting New Zealand* (NZIS 1025) or
- sufficient funds in New Zealand to purchase a ticket to a country to which you have the right of entry.
- any other documents or information requested by a Visa/Immigration officer.

#### For a Visitor's Permit or Limited Purpose Permit you must also supply:

- evidence of onward travel
  - valid ticket to a country to which you have right of entry, or
  - a guarantee of repatriation from a New Zealand citizen or resident friend or relative who lives in New Zealand and is able to be your sponsor. Your sponsor should complete the *Sponsorship Form for Visiting New Zealand* (NZIS 1025) or
  - sufficient funds in New Zealand to purchase a ticket to a country to which you have the right of entry.
- any other documents or information requested by a Visa/Immigration Officer.

#### **Special Provisions exist for:**

- dependent children travelling without parents or with one parent
- · Spouses and de facto partners of New Zealand citizens and residents
- Visitors intending to marry New Zealand citizens or residents

I understand I am responsible for making sure I leave New Zealand before my permit expires and that if I do not I may face removal action.

Only residents or citizens of Australia and the United Kingdom, people holding temporary permits for a stay of 2 years or more, and people approved entry especially for medical treatment, are normally entitled to free use of publicly funded health services in New Zealand. If not entitled to free treatment, I will pay for any health care or medical assistance I or any person included in my application may require in New Zealand.

I authorise NZIS to provide information about my state of health and my immigration status to any health service agency. I authorise any health service agency to provide information about my state of health to the NZIS.

I authorise NZIS to make any enquiries it considers necessary in respect of information provided on this form in order to make a decision on this application and enquiries about my subsequent immigration status. I authorise any agency which holds information (including personal information) relevant to those matters to disclose that information to NZIS.

### **Privacy Act**

The collection of the information is authorised by the Immigration Act 1987 and the Immigration Regulations made under that Act. The supply of the information is voluntary, but if you do not supply it then your application is likely to be declined.

You will, if you come to New Zealand, have a right to access the information about you held by the New Zealand Immigration Service and to ask for any of it to be corrected if you think that is necessary.

Your application should be sent to your nearest New Zealand Immigration Service Branch or New Zealand Embassy or High Commission.
